

LAW, CRIMINAL JUSTICE, AND FORENSICS

This Curriculum Guide **is not** a major or minor plan; it is a list of recommended courses for students interested in pursuing a career in law and criminal justice, such as positions in law enforcement agencies, substance abuse, counseling, work-release programs, juvenile delinquency, and prison facilities.

Note on Pre-requisites: Many of these courses have pre-requisites. Please refer to the current LSA Course Guide for information regarding which courses are required. It is important that pre-requisites are taken early in a student's academic career so that they will be completed in time to take the desired course.
