## **Academic Research**

My research interests lie at the intersection between political sociology and science and technology studies (STS), with a particular focus on medicine. My dissertation concerns the co-construction of deliberative democracy with the emergence of nanotechnology. Federal funding for nanotechnology research led to a series of experiments in deliberative democracy and the governance of emerging technologies. The results are instructive about the role of science and science policy in democratic society. Past projects include research on reproductive technologies, eugenics, infertility, and fetal personhood. I have two future projects currently planned that deal with other aspects of science policy. Methodologically, I employ interviews, historical research, and computational text analysis in Python.

Program Director for Sociology Opportunities in Undergraduate Leadership (SOUL) 2018 - Present The SOUL program aims to promote success among first-generation college students at the University of Michigan. The course involves: (1) an academic class about the first-gen identity, (2) leadership, professional- and life-skills workshops, and (3) a research assistantship in which we study first-gens and UM. I developed and implemented this program from its inception. Working closely with students, I help them explore the first-gen identity and coach them through their semester and beyond. I also manage students through a year-long research project studying first-gens at U of M.
